

# ***You Are Not Free: Courts Have Trapped Us in a Judicial Kleptocracy***

America's justice system is failing. While the public believes courts uphold law and justice, the reality is starkly different: the innocent suffer while wrongdoers are protected. Institutions designed to deliver justice have devolved into a judicial kleptocracy—a system normalizing deception, lawfare, and tyranny to shield unaccountable power.

Most people remain unaware of this corruption until it directly affects them or their loved ones. Even those who recognize it often feel overwhelmed—or too fearful—to act. Courts maintain an illusion of fairness, operating within a closed loop that shields insiders from accountability.

## ***Fraud Upon the Public by the Court: A New Legal Doctrine***

Legal precedent recognizes "fraud upon the court"—when court officers corrupt justice through deception. But what about misconduct by the courts themselves?

We must call this "**Fraud Upon the Public by the Court**"—deliberate judicial wrongdoing designed to maintain unaccountable power, conceal abuses, suppress justice, and silence reform.

This injustice is rooted in courts unlawfully controlling and manipulating grand juries—citizen bodies specifically empowered to independently investigate corruption. Such judicial interference directly violates the Constitution and the Supreme Court's 1992 Williams ruling, which affirmed:

***"...the grand jury is an institution separate from the courts, over whose functioning the courts do not preside."*** (p.47)

***"The grand jury serves as a 'protector of citizens against arbitrary and oppressive governmental action.'"*** (p.68)

## ***The Grand Jury System Has Been Corrupted***

Grand juries were created to protect citizens from government overreach. Instead, prosecutors and judges now control and manipulate them, reducing grand juries to mere rubber stamps rather than instruments of justice.

Even judicial insiders acknowledge this abuse. Sol Wachtler, former Chief Judge of New York's Supreme Court, famously remarked in 1985: ***"Any good prosecutor can get a grand jury to indict a ham sandwich."***

Prosecutors dictate evidence, determine charges, and—critically—decide whether corruption cases are pursued at all. When citizens attempt to expose judicial misconduct, the system shields

wrongdoers and punishes the innocent. As Lord Acton warned in 1887, ***“Power tends to corrupt, and absolute power corrupts absolutely.”***

## **Real-World Consequences of Judicial Corruption**

Unaccountability via judicial kleptocracy has real consequences:

***Wrongful Death Cover-Ups: “George Floyd on Steroids”:*** In Virginia Beach, Rolin Hill—a mentally ill African-American Eagle Scout—was brutally beaten and suffocated by sheriff’s deputies while restrained in June 2024. Officials falsely claimed he suffered a “medical emergency,” despite video evidence from 64 cameras. Following whistleblower revelations and persistent public outcry (see [JusticeForRolin.org](https://JusticeForRolin.org)), three deputies were indicted for murder seven months later. Yet, **electd officials remain unaccountable.**

This cover-up manipulated the 2024 elections, enabling corrupt incumbents to retain power. Officials now acknowledge 20 deaths in the jail over the past seven years. In light of Rolin’s case, each death demands scrutiny. One must ask: **what else is being hidden?**

***Weaponized Prosecutions:*** The lawfare against President Trump and his associates demonstrates how courts have been hijacked for partisan warfare, undermining rule-of-law.

***Erosion of Oversight:*** Corrupt officials co-opt grand juries, ensuring they’re run by handpicked prosecutors and judges, blocking exposure of wrongdoing in all sectors and systems.

These aren’t anomalies—they’re symptoms of a broken system, where legal insiders protect each other while citizens remain defenseless.
